Statement about Israel & Jordan Highlights Tour and Middle East Conflict

We are incredibly saddened by the recent conflict in the Middle East in Israel & Gaza that has impacted so many lives. We hope for security, stability and peace for the region. Premier World Discovery is following the developments surrounding the recent events, and currently has no tours operating in the region. Future tours to Israel have been cancelled through June 30, 2024. We will be in contact with affected groups and travelers, should tour departures after June 30, 2024 continue to be affected.

Statement about West Maui, Hawaii & our Three Island Hawaii Adventure

We are deeply saddened about the wildfires that have caused so much loss of life and destruction to the special town of Lahaina in Maui. We cherish our relationship with the people and islands of Hawaii. It is a magical destination and one that is highly sought out by our guests for its natural beauty, culture and unparalleled experiences. We are closely monitoring the situation in Maui, which impacts the west side of the island.

Regarding your travel plans to Maui, please keep in mind that the state of Hawaii needs travelers as part of their recovery efforts. "In order to recover, we need to strike the proper balance of rebuilding and recovering by continuing to welcome visitors to our shores," said Mufi Hannemann, president and CEO of the Hawaii Lodging & Tourism Association. "With the exception of Lahaina and West Maui area, the remaining resort destinations of Maui remain open, including Wailea, Kihei, Makena and Kahului." According to Tapani Vuori, the general manager of the Maui Ocean Center, "An employed Maui is a resilient Maui. Many of our local businesses depend on the visitor community, and as that dwindles, the hardships on our island multiply." The other islands in the state of Hawaii were not impacted by the fires and remain fully open for tourism.

As we continue to monitor the situation, we are actively reviewing the itineraries of our upcoming 2024 departures. All 2024 departures are scheduled to operate as planned less the Lahaina visit. If any other adjustments need to be made to our 2024 published itineraries, we will advise guests closer to departure.

Currently there are no restrictions affecting any of our other travel programs/destinations.

Our trips throughout the rest of the world are scheduled to operate as planned. Protests and other potential threats often come with conflict, and we are committed to working with our worldwide partners to keep our guests and staff safe.

Future Travel Credit will be issued for Deposit or TPP value in each traveler's name, is Non-Transferable and valid for tours departing within 1 year of the original tour departure date only. Cancellation fee waiver applies to all Premier World Discovery land tours with the exception of those that include specific payment conditions, such as cruises.
